### SAFETY RULES (MUST READ AND SIGN TO PLAY)

1. **Always wear approved goggles on or near playing field and chrono areas.** Not adhering to this rule is cause for immediate dismissal from the games.
2. Never shoot anyone who is not wearing approved eye protection.
3. **No player may shoot his/her marker outside the perimeter of the active playing field.**
4. A player is emphatically disallowed from shooting at any other player showing a neutrality symbol, any non-player, judge, or animal. combat, taking prisoners, etc.
5. **Paintball markers must not have a projectile other than a paintball.**
6. **All paintball markers MUST be chronographed prior to use in play, and shall not exceed 299 FPS. If a ref asks you to chrono you marker you MUST do so!**
7. Observe all safety rules applicable to firearms when handling paintball markers.
8. **At no time will a person strike, throw, or perform any violent act towards another person You will be prosecuted to the fullest extent of the law.**
9. At no time will a player shoot a ref to get his/her attention Doing so is grounds for ejection from the field.
10. Do not shoot across neutral, staging, or parking areas.
11. **No player will cut a hole in the net or shoot their marker directly into the net. Doing so will be grounds for immediate dismissal for life to any events 23bps carries**
12. **Firearms, knives, and explosives are strictly prohibited.**
13. National, regional, state, provincial, and local laws apply.
14. **Consumption of alcohol, including beer, on the premises or in the parking area is prohibited.**
15. 23bps is a NO SMOKING facility .
16. **No physical confrontation between players, i.e. hand – to – hand, is not permitted.**
17. **BARREL SOCK ONLY FIELD.** Paintball markers must have a barrel sock
18. No discharging or dry firing of paintball marker is allowed in any neutral or non – playing areas.
19. Ramping markers, excessive bouncing markers and full auto markers ill not be allowed
20. **Do not use a paintball marker until you have been versed in its use and understand such use.**
21. Never look down the barrel to see if it is dirty.
22. **Paint may not have Red Fill, all other fill colors are allowed.**
23. **23BPS does not offer ANY cash refunds.**

WE MAINTAIN THE RIGHT TO REFUSE PARTICIPATION TO ANYONE ON ANY GROUNDS DEEMED APPLICABLE BY US. THERE ARE NO REFUNDS OF THE FIELD FEE IF YOU ARE ASKED TO LEAVE BECAUSE OF RULE VIOLATIONS. RELEASE / WAIVER OF LIABILITY AND ASSUMPTION OF RISK

### THE UNDERSIGNED

1. Has asked **23bps** to be allowed to play the game of paintball and acknowledges that the game involves physical exertion and other risks, know and unknown that may result injury to the undersigned or others playing the game.
2. Is aware of the possibility of risks of injury, including but not limited to being shot by a paintball, falling, tripping, being hurt by a wild animal, snake bite, heart attack, hypothermia, over heating, insect bites and stings, poisonous plants, improper use or operation of equipment by the undersigned or any other player or spectator not following the safety rules. The possibility of permanent disability or death does exist.
3. Agrees to play the game according to the rules which have been explained and to follow directions given by the game referee.
4. Warrants and acknowledges that his/her physical condition is excellent and his/her mental state is sufficiently stable to enable him/her to participate safely in the game.
5. Agrees to use any paintball equipment in a manner which will not cause injury or damage to him/her or other players.
6. Certifies that he/she is over 18 years old, or has a parent/guardian present to sign for them.
7. Authorizes use of photos, videos, name, comments, game results, etc. For promotional purposes.
8. Understands and agrees to follow all safety rules and procedures.
9. Understands that serious and permanent eye injury, including loss of sight, can occur if approved paintball safety eyewear is not worn in any area where paintball markers may be intentionally or accidentally discharged. I understand that it is my responsibility to wear approved eyewear, and I accept that responsibility.
10. Understands that the safety eyewear can fog or become dirty, and agrees that despite any, or other, such problems that he/she will keep them securely fastened to protect the eyes and will not remove them on the playing field, at the chronograph, at the target range, or in any other area where he/she might be struck by a paintball, other gas powered projectile device used in paintball.
11. Understands that the loss of hearing from an ear shot, disorientation and injury from throat, groin, head, or ear shots can occur if proper safety equipment is not worn to protect these areas, and understands it is his/her responsibility to wear such items. In consideration of being permitted to play the game, the undersigned, on behalf of himself/herself, his/her successors or assigns, hereby release and forever discharge **23bps, AZMazes LLC, John H. Sheely etal, Ken Sheely Ranches Partners, Sheely Farms LLC, Westside PB, LLC,** land owners, land lease holders or managers, equipment distributors, and their successors, assigns, employees, officers, agents, and franchisees, dealers or operators both jointly and severally, from any and all actions, covenant, claims, demands for damages, costs, loss or injury, however arising including negligence, or **23bps**, which may have been sustained by the undersigned in any way relating to or arising out of the playing of paintball, or the equipment including but not limited to, the manufacture, selection, delivery, possession, use or operation of the equipment or the natural environment. The undersigned desires and agrees to assume any and all risks.

THIS DOCUMENT IS INTENDED TO BE A LEGALLY BINDING CONTRACT RELIEVING THE GAME OPERATORS AND EQUIPMENT SUPPLIERS AND THEIR EMPLOYEES FROM LIABILITY FOR THE INJURY TO YOU. IF YOU HAVE ANY DOUBTS CONCERNING ANY ASPECT OF ITS CONTENTS CONSULT AN ATTORNEY BEFORE SIGNING IT. THIS RELEASE OF LIABILITY AGREEMENT COVERS ALL PAINTBALL ACTIVITIES OR EVENTS I PARTICIPATE IN HEREAFTER.
